Chairman Van Geyte discussed how when he was in a real estate meeting a board for southern nh, they had put up a cable tv show based in Londonderry and one of the shows was

on the same subject. Mrs. Boeske wondered if this was something they could promote at the Town Fair or link to their webpage. Chairman Van Geyte proposed having the Ag Commission take it one step further and became a catalyst for helping to place people with these farms. Mr. Boeske suggested helping them to raise money to purchase the starter seeds they need. Mrs. LeBlanc spoke to the liability issues that arose when she worked with the Mustang project because the insurance companies would no longer insure them and they lost their sustainability. Mr. Boeske suggested that the foundation the Bealieau's were working with might help with that.
