Land Use Change Tax Funds Reallocation

Shall the Town rescind the action of the 1997 and 1999 Town Meetings to place 100% of the Land Use Change Tax revenues collected pursuant to RSA 79-A into the Conservation Fund, established in 1997, and instead place Fifty percent (50%) of said funds into the Capital Improvements Plan – Highway Capital Reserve Fund, established in 2015, and the remaining fifty percent (50%) into the Conservation Fund. This action will become effective on July 1 st following the vote.
