**1.4** Approval of Minutes April 10, 2019.

Secretary Knudsen made a motion to approve the minutes from April 10, 2019 as presented. Motion second by Mr. Heuer. NO Discussion. Chair Grimm called for a vote on the motion. The vote was unanimous in the affirmative 4-0.

### b. PACT Coordinator Ms. Demers

1. Equipment Purchase requests – Ms. Demers present the committee with a list of equipment purchases that should be made by end of Fiscal year 2019. The list includes two video racks; BirdDog equipment; 5 Birddog cameras – 1 for BOS, one for Rangeway meetings, 3 for Studio.MPR; replacement PACT control and PACT PC, one laptop PC. The items on the list were presented in the upcoming 2019-20 budget but since the there is a dire need to upgrade the servers and playback systems with the PACT and that the funds are available the items should be purchases now. The total requested amount is \$20,213.00.

Discussion followed.

Secretary Knudsen made a motion to approve the list of items to purchase by the end of June 2019. Motion second by Mr. Heuer. NO Discussion. Chair Grimm called for a vote on the motion. The vote was 3-0 in the affirmative with Liaison D'Angelo abstaining.

Update on new Playback and Announcement system – Ms. Demers presented the system to replace
the Nexus and Tightrope system. The system is a one vendor system with Tightrope that will manage
all three channels and work with the On Demand and streaming system PACT is also providing. The
system price is roughly \$54,545.00 which includes installation and wire running to the BOS room, MPR
and studio.

Discussion followed on how to purchase the new system and if it was needed now or later. Some members felt that the system not only benefits Comcast subscribers but anyone who accesses the On-Demand system and the upgrade benefits all town folks of Chester that an option may be to ask for the Board of Selectmen to incumber the funds. It was agreed upon to go before the Selectmen and see if any funds can be incumbered from the 208-2019 budget or if any other options will work since PACT cannot take out a loan or do a multi-year lease,

3. Volunteer Training will be trying for another date in the near future and is planning on meeting with the Seniors at the Senior center later this month.

# c. Treasurer Report Chair Grimm

Reported that several purchases have been made since last meeting. Town Finance director in process of update the account to reflect expense paid and franchise fees received.

## d. Operations Manager's Report Mr. Heuer

- 1. Update on Studio Equipment Issues since last meeting an issue has been identified with the Cadco Demod that receives the signal from Chester Academy. Trouble shooting has the system working but the process to find a replacement unit is ongoing. The Demods are no longer being manufactured so the search is on for a used one.
- 2. Monitoring of incoming and outgoing signals system is in place and working out very well.
- 3. Electric Update thru Town resources the issue for updating the electric circuits in the PACT location is ongoing. Major issue is that there is not enough Power coming into Town Hall on the current system. Board of Selectmen Liaison Steph Landau is working with electricians on what is needed and pricing.
