Mr. Weider moved to approve the minutes of the 6/14/23 Planning Board meeting as amended. Ms. Richter seconded the motion. A vote was taken. All were in favor. The motion passed 4-0-0.

3. Discuss Colby Farm Lot 5-97 title issue.

Mr. Hadik updated the Board on the Colby Farm Lot 5-97 and North Woods Lot 8-16 title issue. The attorneys have agreed these the title discussions for these lots are separate issues and need to be resolved separately. Attorney Bisson notified Mr. Hadik that the draft warranty deed with deed restrictions has been signed. The Chester Conservation Commission has agreed the warranty deed, easement, and title insurance should be accepted. The developer is providing \$100,000 title insurance in case the portion of the open space that used to be Lot 5-97 is disputed.

4. Colby Farm Construction Update.

Mr. Hadik spoke with Jim O'Brien (field inspection engineer, DuBois & King), who said they have encountered more organic soils than expected in the first 400 feet off Route 121. They will be requesting a field change to build up the road base.
