### 3.1 Spring Hill Farm Advisory Committee

# 3.1(a) High Tunnel Rental:

The Advisory Committee posted notices in the Tri-Town Times and the Chester NH Front Porch Chatter Facebook page with no emails received to date. She noted the High Tunnel Rental consists of the Greenhouse which needs cleaning out plus an acre of land in front of the greenhouse. They would like to get \$500.00 for the season.

# 3.1(b) Workshops:

Ms. Oakley continued noting some of the education classes and lectures discussed, such as:

- Late November wreath making class; nature journaling class;
- NH Beekeepers Association workshop or putting up an apiary on the field;
- "Urban gardens thinking outside the box". This would be a workshop with a demonstration of pruning lilacs.

## 3.1(c) Field Lease:

Ms. Oakley let the Commission know that Mr. Dan Fornier wants to lease some fields for his cows. The Advisory Committee went on a field trip on Saturday March 23<sup>rd</sup> to show him the land. Chair Trask asked about the revenue stream. Ms. Oakley said the Advisory Committee is currently setting up a fund to make money for Committee events. Mr. Fornier will be showing a business plan which will include his sweat equity. Chair Trask asked if Mr. Fornier had to go direct to the BOS and Ms. Oakley noted the first step is through the Advisory Committee.

- **4.1** Ms. Reishus noted she is drafting the annual report later this week and will send out draft to the commission prior to submittal on Monday.
- 4.2 Vice-Chair Kistler noted the Basketball League met and talked about waiting until the end of year in order to create schedule based on November/December game scores. He said there was not a lot of representation other than Epping/Candia/Nottingham and Raymond. Chair Trask asked about Deerfield. Ms. Reishus responded there are not enough teams to split into a smaller town division.
- 4.3 Ms. Reishus updated the Committee regarding Soccer program this spring. She noted we wouldn't drop porta potties on the town fields for baseball. They had paid for 2 months last year and we don't have a Baseball program. She continued that Wason Pond will have one regular and one handicap units on the playground before April school vacation and then will add additional units at the beach before Memorial Day. She will then look at the budget to see if we can add more porta potties on the fields.
